

# Happy Healthy Together CIC

## Terms and Conditions for Parent and Child Activities

---

### **1. About these terms**

These Terms and Conditions apply to all parent and child activities, workshops and sessions delivered by Happy Healthy Together CIC. By booking onto or attending an activity, parents and carers confirm that they have read, understood and agreed to these Terms and Conditions.

### **2. Responsibility for children**

Parents and carers remain responsible for the supervision, safety and behaviour of their child(ren) at all times during activities. Happy Healthy Together CIC does not provide childcare, and children must not be left unattended unless a session is clearly advertised as a drop-off activity and written consent has been provided.

### **3. Participation and behaviour**

All participants are expected to behave respectfully towards others, staff, venues and the environment. Disruptive, aggressive or unsafe behaviour may result in parents and children being asked to leave an activity.

### **4. Health, medical information and additional needs**

Parents must disclose any relevant medical conditions, allergies, additional needs or accessibility requirements at the time of booking. Parents remain responsible for administering medication unless otherwise agreed in writing.

### **5. Safety and instructions**

Participants must follow all safety instructions provided during activities. Suitable clothing and footwear must be worn. Activities may be adapted or stopped where safety is compromised.

## **6. Risk acknowledgement**

Some activities involve inherent risks, including physical activity or outdoor environments. By attending, parents acknowledge these risks and accept responsibility for their child's participation.

## **7. Accidents and emergencies**

In the event of an accident or injury, parents remain responsible for the immediate care of their child and for seeking medical assistance. Staff may provide basic first aid within the limits of their training.

## **8. Safeguarding**

Happy Healthy Together CIC is committed to safeguarding children and promoting their welfare. Safeguarding concerns may result in information being shared with appropriate agencies where a child's welfare is at risk.

## **9. Photography and recording**

Photography or recording may only take place with parental consent. Parents may be asked not to photograph other children to protect privacy.

## **10. Data protection**

Personal information provided during booking will be processed in line with UK data protection legislation and our Data Protection Policy.

## **11. Cancellations and changes**

Parents should notify Happy Healthy Together CIC if they are unable to attend a booked session. Activities may be cancelled or rescheduled due to unforeseen circumstances.

## **12. Equality and inclusion**

Happy Healthy Together CIC is committed to equality, diversity and inclusion. Discriminatory behaviour will not be tolerated.
